Section 4: First-Aid Measures

4.1 Description of first aid measures

General advice

If inhaled

Section 6: Accidental Release Measures

6.1 Personal precautions

Use personal protective equipment. Avoid dust formation. Avoid breathing vapours, mist or gas. Ensure adequate ventilation. Evacuate personnel to safe areas. Avoid breathing dust.

Prevent further leakage or spillage if safe to do so. Do not let product enter drains.

6.3 Methods and materials for containment and cleaning up

Sweep up and shovel. Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container for disposal according to local regulations. Keep in suitable, closed containers for disposal.

7.1 Precautions for safe handling

Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Provide appropriate exhaust ventilation at places where dust is formed.

Air and moisture sensitive. Never allow product to get in contact with water during storage. Keep container tightly closed in a dry and well-ventilated place.

Respiratory protection
