Section 4: First-Aid Measures

4.1 Description of first aid measures

General advice

7.1 Precautions for safe handling

Put on appropriate personal protective equipment. Contains gas under pressure. Avoid breathing gas. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not puncture or incinerate container. Use equipment rated for cylinder pressure. Close valve after each use and when empty. Protect cylinders from physical damage; do not drag, roll, slide, or drop. Use a suitable hand truck for cylinder movement.

7.2 Conditions for safe storage

Contents under pressure.

Keep away from combustible materials and sources of ignition.

Keep container tightly closed in a dry and well-ventilated place.

Respiratory protection
